Other Critical and Essential Roles that the 5 BOD Members will Appoint Include: Treasurer, Secretary, Youth Member Coordinator, Adult Member Coordinator and Committee Chairs/Members. Except for the Youth Member Coordinator, these positions are 1 year Terms, from January to December, with renewal on an annual basis. The Youth Member Coordinator Term is also one year but the term will run from August to July, with renewal on an annual basis.

All Elected Positions will commence on January 1st and conclude on Dec 31st of any given year depending on Term Length. The Newly Elected BOD will Appoint these Critical and Essential Roles as soon as the newly Elected BOD is seated.

<u>To Run for BOD:</u> Send an email to **secretary@rowlcra.org** identifying the position you are interested in with a photo and brief description of your qualifications and reasons for running for the position.



**All 5 BOD Members** will be expected to Energetically Support the Lake County Rowing Association (LCRA) Vision and Mission and shall actively engage the Club in the following ways:

- 1. Establish a working knowledge of Club Operations, Financials, Coaching and Support Staff.
- 2. Facilitate the interface, relationship and transactions with the Clermont City and Lake County Leadership for the purpose of supporting LCRA Vison, Mission and Operating Plans.
- 3. Sponsor or Chair one or more Committees.
- 4. Engage the Club Members during the year by attending at least 2 Regattas.
- 5. Attend two "Ride-Along" practices, each, with the Youth Head Coach and Adult Head Coach to better understand the Coaching needs.
- 6. Attend Routine Board Meeting and gatherings as required.
- 7. Establish Goals and Benchmarks for Fund Raising, specifically including Board Member commitments relative to same.

#### **President**

The President shall coordinate and supervise the activities of all other officers of the Corporation. The President shall from time to time, call special meetings of the Board of Directors whenever the President deems it necessary to do so or whenever the requisite number of the members of the Board of Directors shall request in writing that the President do so. The President shall preside at all meetings of the Directors and shall generally perform such other duties as are delegated by the Board of Directors and such duties as are usually pertaining and attributed by law. The President, unless some other person is thereunto expressly authorized by resolution of the Board of Directors, shall sign all certificates of stock, execute all contracts, deeds, notes, mortgages, bonds and other instruments and papers in the name of the Corporation and on its behalf; subject, however, to the control, when exercised, of the Board of Directors. The President shall, at each annual meeting, present a report of the business and affairs of the Corporation, and shall from time to time, whenever requested, report to the Board all matters within his knowledge, which the interest of the Corporation may require to be brought to the notice of the Directors. The President shall have direct reporting oversight for all coaches hired by the Board (cont.)

#### President (cont.)

The President shall have the power to employ and terminate the employment of all such subordinate agents, clerks, and other employees not herein provided to be selected by the Board, as he may find necessary to transact the business of the Corporation, and shall have the right to fix the compensation thereof. In general, the President shall perform all duties incident to the office of President and such other duties as may be prescribed by the Board of Directors from time to time.

#### **Vice President**

The Vice-President shall act in the place and stead of the President in the event of the President's absence, inability, or refusal to act, and shall exercise and discharge such other duties as may be required of him by the Board of Directors.

#### **Youth Rowing Board Member (YRBM)**

The Youth Rowing Member Rep shall serve a term of two (2) years and shall be elected by the Youth Membership. They sit as a Full and Equal Voting Board Member.

#### **Adult Rowing Board Member (ARBM)**

The Adult Rowing Member Rep shall serve a term of two (2) years and shall be elected by the Adult Rowing Membership. They sit as a Full and Equal Voting Board Member.

#### **Community Representative Board Member (CRBM)**

The CRBM must not be a current active Member or Parent of an active Youth Member within the last two (2) years in order to provide unbiased input and advice. They must be in good standing in the Lake County community. The Community Representative Board Member shall be appointed by three-fourths (3/4) of the Board of Directors and serve a term of two (2) years.

Note: No individual may hold multiple positions on the Board.




